IDEA AND IEPS

THEN AND NOW

History of Special Education in the U.S.

- The Individuals with Disabilities Education Act (IDEA), originated in 1975 (Education for All Handicapped Children's Act of 1975 or PL 94-142). It is our <u>nation's special education</u> law. Most recent update=2004.
- IDEA requires that schools find and provide a Free and Appropriate Education (FAPE) to students suspected of having a disability in the Least Restrictive Environment (LRE), at no cost to the parent. This education should emphasize "special education and related services designed to meet a child's unique needs". (Section 300.111)
- IDEA protects the rights of children with disabilities and their parents.
- IDEA covers children birth-21 years (May be 22 ½ in California, depending on the student's birthdate) or until they receive a high school diploma (whichever happens first).
- IDEA drives Individualized Education Programs (IEPs), as well as the California Ed Code.

What's happening now???

- There has been an exponential growth in the number of children requiring special education support:
- Autism
- Dyslexia
- Specific Learning Disability
- Other Health Impaired
- Section 504 Plans



Current Status of Special Education

Unfortunately, the current "system" is broken. IEP teams are currently overworked, over-caseload, and doing their best with what they have been given.

Funding has not increased although the number of children requiring special education services has increased <u>exponentially</u>. Congress' promise of <u>40</u>% funding of extra cost of special education has been only about <u>14.6</u>% in actuality. <u>New Relief Bill</u>


Solution: As parents, professionals, and allies, we can learn to work *collaboratively* with schools and IEP teams so that children are afforded the Free and Appropriate Education (FAPE) afforded them under the law (IDEA).

Final Note: The school/school district is **not** our *"enemy"*. Education is a **BUSINESS**! We can learn to handle ourselves in a professional, business manner.

5 Tips to Prepare for Your Best IEP Meeting Yet!









Tip #1: Take Time to Review and Prepare

- Review your IEP documents; do you have a copy of the final IEP from your last meeting?
- Request a copy of your upcoming IEP document and assessment reports (if applicable)
- Organize past IEP documents (binder, computer, etc.)
- Create a separate email account



Tip #2: Parent Input Statement

- Create a concise 1-2 paragraph statement
- Your "vision statement" for this year's IEP
- Add a note regarding your child's strengths, challenges, interests, and goals for the future
- Also add your top 1-2 areas of concern that you want to address this school year.



Tip #3: Record Your IEP Meeting

- 24-hours notice to inform the team that you will record
- If possible, use a digital recorder and have batteries on hand
- Evidence for the future

Tip #4: Don't Go it Alone!

- If at all possible, bring someone with you to every IEP meeting
- Moral support
- Emotional support
- Options: Regional Center Service Coordinator, private therapists, advocate, family member, etc.



Tip #5: Watch Your Words

- Prepare your questions prior to the meeting
- Ask for clarification
- "Best" versus "Appropriate"
- Meaningful Parent Participation
- Trigger words



Do This! ~ YES

- Ask clarifying questions
- State the facts
- Send short and sweet emails; 5 sentences or less when possible
- Use bullet points
- Refer to "a "reliable reporter"

<u>Avoid These ~ NO</u>

- Emotionally charged words (negligent, impossible, safety)
- Snarky or passive aggressive tone to emails
- **Bold**, ALL CAPS, *italicized*
- Making demands or threats
- Placing emphasis on your opinion
